If the unutilized banked energy as on 31.3.2021 is higher than the quantity banked in FY 2019- 20, roll over of banked energy to the extent of the difference in the quantum of FY 20 and FY 21 may be permitted for adjustment excluding peak hours i.e adjustment of energy may be permitted during normal and off-peak hours, for the period from 28-12-2021 to 31.3.2022.”*
