ORDER:

In G.O. Ms No.80, Energy Department, dated: 19.8.2002 Government had issued orders for sanctioning an amount of Rs.4000/- p.m. as Transport Allowance to the Secretary, Director (Tariff) , Director (Engineering) and Director (Legal) of the Tamil Nadu Electricity Regulatory Commission

2. The Chairman, Tamil Nadu Electricity Regulatory Commission has stated that, it is nearly 8 years since the rates were fixed. The petrol price was Rs.31.44 per litre on 19.8.2002 and the current price is Rs.51.59/Ltr. representing an increase of 64% . The price of diesel was Rs.19.86/- Litre. on 19.08.2002 and current price is Rs.37.78/Ltr. representing an increase of 90%. He has further stated that in G.O. Ms.No.169, Finance (BG I) Department dated 16.05.2002, a lump-sum allowance of Rs.12,000/- per month has been sanctioned for the Officers who are entitled to staff cars.

3. The Chairman, Tamil Nadu Electricity Regulatory Commission has requested the Government, to enhance the Transport Allowance to the officers i.e., Secretary , Director (Tariff), Director (Engineering) and Director (Legal) of the Tamil Nadu Electricity Regulatory Commission from Rs.4,000/- to Rs.12,000/- per month.

4. After careful examination, the Government, direct that the Transport Allowance to the officers i.e., Secretary, Director (Tariff), Director (Engineering) and Director (Legal) of the Tamil Nadu Electricity Regulatory Commission be enhanced from Rs.4,000/- to Rs.12,000/- per month.

5. This order issues with the concurrence of Finance Department vide its U.O.No 50640/PW.II/2010,dated:08.09.2010.
