Notification No. TNERC/Regulations/F&F/4/2-3 dated 17-6-2008

Whereas the Tamil Nadu Electricity Regulatory Commission, in exercise of its powers conferred on it by clause (g) of sub-section (1) of section 86 of the Electricity Act, 2003 (Act 36 of 2003), specified and notified in the Tamil Nadu Government Gazette dated the 18th February 2004, the Tamil Nadu Electricity Regulatory Commission Fees and Fines Regulations, 2004:

And whereas it is considered necessary to issue amendments to the said Regulations for the purpose of removing certain difficulties in regard to making provision for collection of fees in respect of certain functions which were not distinctly covered earlier, and the same have undergone previous publication;

Now, therefore, in exercise of the powers conferred on it by clause (g) of sub-section (1) of section 86 of the Electricity Act, 2003 (Act 36 of 2003), and all other powers enabling it in that behalf, the Tamil Nadu Electricity Regulatory Commission makes the following amendments to the Tamil Nadu Electricity Regulatory Commission – Fees and Fines Regulations, 2004 (hereinafter referred to as the Principal Regulations)

TAMIL NADU ELECTRICITY REGULATORY COMMISSION Fees and Fines (Second Amendment) Regulations 2008

1.Short Title and Commencement:

(i) These Regulations may be called the Tamil Nadu Electricity Regulatory Commission Fees and Fines (Second Amendment) Regulations 2008.

(ii) They shall come into force from the date of their publication in the Tamil Nadu Government Gazette.

2.Amendment of Regulation 6 of the Principal Regulations

In the Table under regulation 6 of the Principal Regulation,

(i) after item 4 and the entries relating thereto, the following Note shall be inserted, namely:-

"Note :- In cases where the Commission declines to approve a power purchase agreement, the fees paid at the time of filing the said application shall be refunded after deducting any reasonable expenses incurred by the Commission in processing the said petition or application, as may be decided by the Commission"

(ii) for item 6 and the entries relating thereto, the following items and entries relating thereto shall be substituted, namely :-

6 (a) Miscellaneous applications filed by individuals not covered by other listed categories

Rs. 500/-

(b) Miscellaneous applications not	
covered by the other listed categories	
and filed by any organisation registered under the	
Companies Act 1956 (Act 1 of 1956)or	
any firm or other Corporate body	Rs. 5,000/-
(c) For any Interlocutory Application in any main	

petition filed before the Commission Rs. 100/-
