### Amendments to Fees and Fines Regulations 2004

(Notification No.TNERC / Regulations /F&F/4/2-8, dated 13-5-2014)

No.VI(2)/134/2014.

In exercise of the powers conferred by Clause (g) of sub-section (1) of Section 86 read with Section 181 of the Electricity Act, 2003 (Central Act 36 of 2003) and all other powers enabling it in this behalf, the Tamil Nadu Electricity Regulatory Commission hereby makes the following amendments to the Tamil Nadu Electricity Regulatory Commission - Fees and Fines Regulations, 2004, the draft of the same having been previously published as required by sub-section (3) of Section 181 of the said Act.
