Tamil Nadu Electricity Regulatory Commission-State Advisory Committee (Amendment) Regulations-2008

(Notification No. TNERC/SACR/2-8, dated 3rd June 2008.)

Whereas the Tamil Nadu Electricity Regulatory Commission specified and notified the "Tamil Nadu Electricity Regulatory Commission-State Advisory Committee Regulations-2004" under sub-section (1) of Section 87 of the Electricity Act. 2003 (Central Act No. 36 of 2003) and published in Part VI—Section 2 of the Tamil Nadu Government Gazette (Supplement), dated the 18th February 2004.

And Whereas it is considered necessary to issue Amendment to the sub-regulation (4) of Regulation 12 of the Tamil Nadu Electricity Regulatory Commission - State Advisory Committee Regulations-2004, and such amendment shall be subject to the condition of previous publication and accordingly have undergone such pervious publication;

Now, therefore, in exercise of the powers conferred on it by sub-section (1) of Section 87 of the Electricity Act, 2003 (Central Act No. 36 of 2003) and all other powers enabling it in this behalf, the Tamil Nadu Electricity Regulatory Commission hereby specifies the following Amendment, namely:—

- 1. Short title and commencement:
- (a) This Regulation may be called the Tamil Nadu Electricity Regulatory Commission State Advisory Committee (Amendment) Regulation-2008.
 - (b) It shall come into force on the date of its publication in the Tamil Nadu Government Gazette.
- 2. Amendment of Regulation 12 of the Tamil Nadu Electricity Regulatory Commission State Advisory Committee Regulations-2004:

For sub-regulation (4) of Regulation 12 of the Tamil Nadu Electricity Regulatory Commission-State Advisory Committee Regulations-2004, the following sub-regulation shall be substituted, namely:—

- "(4) For the members other than those who are governed by sub-regulation (3) above, the payment of daily allowance shall be at the rates specified by the Commission from time to time which may also be indicated in their appointment orders. The payment of TA shall be as follows:—
- (a) for the members whose normal station of residence is connected with either rail head or air head, or both, the actual train fare or actual air fare on production of tickets or altenatively a lump sum equivalent to AC 2tier shall be paid by the Commission.
- (b) for the members whose normal station of residence is neither connected with rail head nor air head, a lump sum equivalent to the AC 2 tier fare from the nearest rail head shall be paid by the Commission".
